

**ONLINE ACCEPTANCE OF THE TERMS OF USE OF “Island Mykonos
Travel” WEBSITE**

1. Terms of Use

This website, www.discovergreece.org is owned by “CH. PANTAZOPOULOS MYKONOS TOURISM AND COMMERCIAL ENTERPRISES LTD.”, with the distinctive title “Island Mykonos Travel” and is protected under the provisions of L. 2121/93 on intellectual property, as currently in force.

The users /visitors (hereinafter: “User”) of this Website (hereinafter: “Island Mykonos Travel”) must read carefully and consent to the following terms of use and service conditions before entering or using the web pages and our services. Any users refusing to consent to such terms must refrain from such use.

The following terms of use apply to all contents of our Website and everything included in or posted on its pages. Island Mykonos Travel can freely modify such terms and conditions of use any time. Any amendment to the terms hereof shall apply and form part of this agreement only if executed in writing and integrated herein.

User must check for any amendments before use. Use of the website shall be construed as acceptance of any amendments to the terms and conditions of use. Users must refrain from entering / using our Website unless they consent to all amended terms.

2. Intellectual and industrial property rights

This information is not disclosed to third parties (save where such disclosure is required under the Law, and then only to the competent authorities) but is treated as confidential. Our Website maintains records of such data exclusively for communication, statistical and service improvement purposes and for the purpose of facilitating the services offered to the customers of Island Mykonos Travel and our Website users.

With regard to any “links” to other websites, Island Mykonos Travel is not liable for the data protection and management terms applied by such other websites.

In any case, our Website users can contact the competent department and request erasure, correction or alteration of their data. Access to our Website is granted to minors only on parental consent.

6. Restriction against advice
